RELEASE OF LIABILITY, WAIVER, AND ASSUMPTION OF RISK AGREEMENT

In consideration of being allowed to participate in any surfing instruction, equipment rental, and/or related activities,

I, _____ (print Surfer's name) being an adult (or minor on whose behalf a parent or legal guardian is signing this document) acknowledge and fully agree to the following disclosures:

- 1. Risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist.
- 2. I Acknowledge That Surfing May Be Dangerous And I Accept And Assume Such Risks, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation: I am aware that open water activities in general, and surfing specifically, involve inherent risks.
- 3. I willingly agree to release OCEAN OUTFITTERS and any of its employees from responsibility and waive all my rights to take any legal action against them. If I observe any unusual or significant hazards during my presence or participation in this activity I understand that it is my responsibility to remove myself from participating and bring such to the attention of the nearest official immediately.
- 4. I Waive My Right To Sue OCEAN OUTFITTERS: In consideration for OCEAN OUTFITTERS agreeing to provide me with equipment rental or surfing instructions and/or allowing me to participate in this lesson, I agree that I shall not make a claim or bring any action against, sue, or hold responsible OCEAN OUTFITTERS, its owners, officers, agents, employees, associates, representatives, (referred to collectively in this agreement as "OCEAN OUTFITTERS") or expect, require, or pursue them, to be held accountable for any damages. I voluntarily agree to release, discharge, and hold harmless OCEAN OUTFITTERS from and against any and all claims of liability, even those arising out of their negligence, fault, recklessness, or any other act or omission which causes me damages, illness, injury, disease, or death, of any nature in any way connected with my participation in this activity. I also expressly agree to release and discharge OCEAN OUTFITTERS from any act or omission in rendering or failing to render any type of rescue, emergency or medical services.
- 5. I agree to replace and/or compensate for all or any equipment damaged, lost or stolen due to my negligence.
- 6. I, for myself and on behalf of my heirs assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS, OCEAN OUTFITTERS, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasee"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damages to personal property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE, to the fullest extent permitted by the law.
- 7) I have read this document in its entirety and it is my intention that it be broadly construed in favor of OCEAN OUTFITTERS in the event of any ambiguities, which shall be resolved in OCEAN OUTFITTERS' favor. I understand that I am assuming all the risks inherent in this surfing activity, and that I may be injured, become ill, or even die as a result of surfing. I understand that this is a release of any and all claims. I understand that this is the entire agreement between me and OCEAN OUTFITTERS, and that no representations have been made to me by OCEAN OUTFITTERS outside of this agreement. I voluntarily sign my name as evidence of my acceptance of all the provisions in this release and my agreement to be bound by them.
